Opening of Financial Bid

- 2. In case, any holiday is declared by the Government on the day of opening of the tender, the tender will be opened on the next working day at the same time but the tender box will be sealed on the scheduled day and time.

Terms & conditions:

Marg, New Delhi, in the presence of representatives of those bidders who may wish to be present.

- 8. The tenderer should take care that no column in the tender document should be left blank which would be otherwise making the tender liable for rejection.
