The Income Tax Department, North Eastern Region is pleased to invite applications from eligible advocates for empanelment as **Special Public Prosecutors** to represent the Income Tax Department before the Courts of Session and its subordinate Courts in the North Eastern Region. The eligibility terms and conditions are as per Instruction No. 6/2016 dated 07.09.2016 issued by the Government of India, Ministry of Finance (Department of Revenue), Central Board of Direct Taxes, New Delhi. The terms and Schedule of fees payable to prosecution Counsels will be as per the Instruction No. 6/2016, F .No. 279/Misc/M-77/20II-ITJ. ### Eligibility Criteria:

- 1) Special Public Prosecutors: A person should
  - a) be eligible to appear before the Court as an advocate and
  - b) have a minimum experience of Seven years as a Practicing Advocate, in criminal matters. Adequate experience of handling trials relating to Direct Taxes is desirable.

<u>Period of engagement</u>:- The first engagement of Special Public Prosecutor shall normally be for a period of eighteen months.

Termination: - By written communication from either side without assigning any reason.
