2. Tendering process:

- 2.1 The bidder shall be allowed a site visit to inspect the volume of work at any time within the Office hours (9:00 AM to 5:30 PM), prior to submission of bids.
- 2.2 Tender is invited in two parts, i.e. (1) Qualifying bid and (2) Financial bid. The tender form for qualifying bid in the proforma prescribed in Annexure – I and the tender form for the financial bid in the proforma in Annexure – II complete in all respects shall be put in two separate sealed covers. The two covers are to be put in another single cover sealed and submitted to the office of the Joint Director of Income Tax (Investigation), Thiruvananthapuram. The inner sealed covers may be super scribed "Qualifying Bid - Contract for Supply, Installation & Commissioning of Branch Router, Ethernet Switch and related accessories" & "Financial Bid - Contract for Supply, Installation & Commissioning of Branch Router, Ethernet Switch and related accessories" respectively. The outer cover shall be superscribed "Tender for Supply, Installation & Commissioning of Branch Router, Ethernet Switch and related accessories" and it should be addressed to the Joint Director of Income Tax (Investigation), 5th Floor, Aayakar Bhavan, Typm.- 695 003.
- 2.3 The bidder shall sign and stamp each page of this tender document as token of having read and understood the terms and conditions contained herein and submitted during office hours on all working days on or before 01st December 2022 till 04:00 P.M. The tender forms shall be rejected if it is not complete in any aspect. Late submission of tenders shall not be accepted.
- 2.4 The tenders shall be opened by the Committee constituted for this purpose at a later date (to be intimated separately) at O/o the Joint Director of Income Tax (Investigation), Aayakar Bhavan, Kowdiar, Thiruvananthapuram in the presence of the bidders who wish to be present.
- 2.5 The Competent Authority reserve right to cancel or accept any or all the Tenders without assigning any reason. The valid qualifying bids shall be scrutinized by the Department to shortlist the eligible bidders. Thereafter, the financial bids of the short listed bidders shall be opened.
- 2.6 The successful bidder of the contract has to submit a Performance Security by way of Bank Guarantee receipt in favour of the Joint Director of Income Tax (Investigation), Thiruvananthapuram and equal to 3% of the bid amount (inclusive of taxes) rounded to nearest multiple of Rs.1000 (Rupees One thousand only) within three working days from the day of awarding the contract.
- 2.7 Price quoted should be inclusive of all taxes, fees, charges etc. and nothing above the quoted price shall be paid under any circumstances. Price quoted shall be final and no escalation / revision shall be allowed.

3. Instructions to Bidders:

- 3.1 The supplier cum contractor should have at least 3 years experience of similar work and they should submit at least one work order as proof. The bidder is also to submit copies of ITR-Vs of previous three years.
- 3.2 The applicant tenderer should not have been blacklisted or debarred from participating in the tenders at any point of time by any of the Central or State Government, Semi Government or Local Body Agencies. An undertaking to this effect shall be submitted.
- 3.3 Participation in the tender process does not by itself give the bidder any commitment from the Department. The Department will not be liable for any damage / loss caused to the bidder during the tendering process and before signing of the contract. The Department reserves the right to reject any / all offers without assigning any reason. All disputes lie within the jurisdiction of Thiruvananthapuram City.
- 3.4 Registration certificate issued by State or Central Government as Contractor, if available should be submitted. The supplier should also have PAN and GST registration and should submit copies thereof.

4. Conditions of contract:

- 4.1 Successful bidder should commence work within five days of awarding of bid and issue of Letter of Award (LoA). The successful bidder should also complete the proposed work within a period of 45 days from commencement of work, failing which the bidder is liable to be penalised.
- 4.2 Satisfactory installation, Commissioning and Handover of the items in above BOQ means faultless functioning including system integration of all equipments for a minimum period of 60 days from date of handover.
- 4.3 <u>Guarantee / Warranty:</u> The tender must be quoted with a "Three years comprehensive onsite Warranty / Guarantee" which shall be considered from the date of satisfactory installation of items against defects in manufacturing, Workmanship and poor quality of components as in BOQ in Annexure III.
- 4.4 Bidder shall solely bear all costs associated with preparation and submission of bids. This office shall in no case be responsible or liable for such costs, regardless of the conduct or outcome of the tender process. In no case, such costs shall be reimbursed by this office.
